***Party 1 (Proprietor/Owner's Name/Applicant) agrees to the terms and conditions of this contract as listed below:***

1. The fee for reserving an area for a **FOOD BOOTH** will be as follows: \$475.00 with a \$50.00 Cleaning Deposit.
2. In addition to the fee for reserving a booth space, there will be a \$50.00 cleaning fee deposit, which will be refundable if the area occupied and the immediate area four feet surrounding the tent/booth/truck is absolutely clean and litter free. Deposit will not be returned if area is not clean or in the same condition that was left for you to use.
3. PAYMENTS MUST BE MADE IN CASH, MONEY ORDER, CASHIER'S CHECK, OR CREDIT CARD (VIA PAYPAL) (NO EXCEPTIONS). THERE WILL BE A 2.5% TRANSACTION FEE IF PAYING BY CREDIT CARD. PAYMENT MUST BE COLLECTED BY \_\_\_\_\_. PERSONAL CHECKS WILL NO LONGER BE ACCEPTED. IF *PARTY 1*'S REQUEST FOR CANCELLATION IS AFTER PAYMENT IS MADE, NO REFUNDS WILL BE GIVEN.
4. Notes: A) Booths are available on a first-come, first-serve basis, Party 1 must provide their own tent or booth if Philippine Weekend Booths are taken.
5. *Party 1* will conduct its business only in the area of space allotted to them by the Food Vendor Chairperson. Should Party 1 attempt to conduct business in any other area or in an area greater than the space allotted, then the Philippine Weekend Committee has the right to terminate this contract and no refund will be given.
6. *Party 1* will not infringe in any way, shape, or form upon the space of any other Party participating in the festival. Should Party 1 infringe upon another food vendor's space, the Philippine Weekend Committee has the right to terminate this contract and no refund will be given.
7. The Philippine Weekend Committee will not be liable for any injuries occurring within the confines of the tent/booth.
8. The Philippine Weekend Committee will not be liable for any of *Party 1*'s property that is either lost or stolen within the confines of the tent/booth.
9. The Philippine Weekend Committee will not be liable for any unlawful activity or act committed by any person or business participating under this contract at the Philippine Weekend Event.

10. *PARTY 1* AGREES TO INDEMNIFY, DEFEND, AND HOLD HARMLESS PHILIPPINE WEEKEND, INC., FROM AND AGAINST ANY AND ALL CLAIMS, LOSS, COST, OR DAMAGE OF ANY KIND (INCLUDING REASONABLE OUTSIDE ATTORNEYS/CONSULTANTS' FEES) ARISING OUT OF, INVOLVING, OR IN CONNECTION WITH, *PARTY 1*'S BREACH OF THIS CONTRACT, AND/OR ITS NEGLIGENCE OR WILLFUL MISCONDUCT.
11. **The Philippine Weekend Committee will NOT supply ANY electrical power that *Party 1* may need.**
12. *Party 1* will be responsible for acquiring and meeting all Kern County Department of Health services licensure, materials, and equipment to legally and safely operate in their rented or self-provided tent or booth.
13. *Party 1* will be responsible for having all legal licensure needed to operate a business.
14. *Party 1* will submit copies of all requirements (as requested) to Philippine Weekend Committee with the reservation/usage fee.
15. *Party 1* is entering into this contract and participating in the Philippine Weekend Event willingly and of its own choice. Should *Party 1*'s endeavor as a participant proves to be unsuccessful, the Philippine Weekend Committee will not be held responsible for any losses and no refunds will be given.
16. *Party 1* **WILL NOT** sell any liquid refreshments, SODAS, or WATER. Only two vendors will be able to sell Boba and shaved ice, this is chosen by a lottery only by the Philippine Weekend Committee. If *Party 1* is caught selling or distributing ANY liquid refreshments during the festival, Philippine Weekend, Inc. has the right to terminate the contract and *Party 1* will not receive any refund. No liquid items will be given out as samples at any booth.
17. *Party 1* **WILL NOT** interfere with the discretion of the Food Vendor Chairperson under any conditions.
